2. You can use a giving envelope for cash or cheques made out to Downham Baptist Church and place them in the offering. Be sure to write your giver number or name on the envelope so we can have a record of your donation.

GIFT AID - Frequently Asked Questions (FAQs)

Who can give by GIFT AID?

Any adult who pays Income Tax, whether through PAYE, business income or investments.

What if I stop paying tax?

Please advise DBC immediately as DBC will not be able to reclaim tax on gifts made in that tax year.

What if I move?

Just let us know. We will send you a new Gift Aid Declaration to fill in.

Can I give by putting cash into the offering bags?

Yes, but we can only claim back the tax if we have evidence of the gift and who gave it. The Inland Revenue suggest using envelopes.

What should I do if my personal details change?

If you change your name or address, please let us know and we will send you a new Gift Aid Declaration to fill in.
